Application Procedures

Application Submission

- 1) Register as user and submit through Technology Voucher Programme Funding Administrative System.
- 2) Upload with required documents.
 - ◆ Copy of Business Registration (BR) Certificate, copy of Form 1(a) of BR Office or Form NAR1 of Companies Registry.
 - ◆ Mandatory Provident Fund records.
 - ◆ All issued quotation/ tender invitation documents
 - ◆ Copy of BR Certificate of technology consultant (if applicable),
 - ◆ Copy of identity proof of signatory on application form.
 - ◆ All issued quotation/ tender invitation documents

Implementation

- 1) Successful application to sign a funding agreement with ITC before project commencement.
- 2) Project to be completed within 12 months and submit final report.

Application Requirements

- Non-listed enterprises that aims to use technological services and solutions to improve productivity, or upgrade or transform their business processes.
- ◆ Registered under the Business Registration Ordinance (BRO) (Cap. 310).
 - ◆ With substantive business operation in Hong Kong which is related to the project under application at the time of application.

Application Assessment

- Each eligible application will be assessed based on individual merits and considered on a case-by-case basis.
- ◆ Relevance to business of the applicant.
 - ◆ Reasonableness of budget and implementation details.
 - ◆ Adverse record of technology consultant and / or service provider(s).

Disbursement Of Funds

- Applicant enterprise should submit the following documents within 2 months after completion of the TVP project:
- ◆ A final project report with summary of project expenditures and deliverables.
 - ◆ Evidence of deliverables.
 - ◆ Original or copy of receipt(s) certified by the applicant enterprise in relation.
 - ◇ if the approved funding exceeds \$50,000, an audited statement of expenditure for the project from an independent auditor is required to be submitted to ITC.
 - ◇ if the approved funding is HK\$50,000 or below, applicant enterprises are required to submit a final statement of expenditure and declare the final statement of expenditure.
 - ◇ Funding on no more than two-thirds of the actual cost of project.
